**Board of Studies in Food Technology**

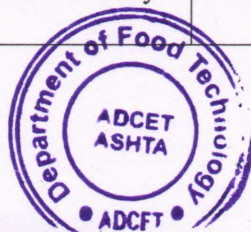


